- 1. Enhanced Skills for Sustainable and Rewarding Employment (ENSSURE)-II is a bilateral initiative of the Government of Nepal (GoN) and the Government of Switzerland implemented by 3 tiers of government at Federal, Provincial and Local level with technical assistance from Helvetas Nepal. The overall goal of the project is to contribute for improved living standard of Nepalese workers particularly from disadvantaged groups to benefit from continuous employment.
- 2. Biratnagar Metropolitan City now invites Expression of Interest (EOI) from interested eligible Consultant or TPs to Train 20 participants in Professional Cook, 20 participants in Professional Aluminum Fabricator and 20 participants in Professional Plumber (Level II with 1696 hrs. for each program) under Training with OJT in FY 2079/080 as mentioned in the Terms of Reference (TOR).
- 3. The training should be based on the minimum standards outlined in the CTEVT approved curriculum and National Occupational Skill Standards (NOSS) of the National Skills Testing Board (NSTB).
- 4. Interested eligible Consultant or TPs may obtain further information at the Biratnagar Metropolitan City Office, Biratnagar, Morang during office hours on or before 2079/12/16 and EOI document shall be obtained free of cost at website of municipality https://www.biratnagarmun.gov.np.
- The training events must be conducted in the venue/s having adequate training facilities for the proposed occupation/s. Conducting trainings in temporary (Mobile based) settings are not allowed and it should be conducted in the suitable location of Biratnagar Metropolitan City, Biratnagar, Morang.
- 6. Documents of the experience and other evidence copies of certificates shall be duly notarized.
- 7. Expressions of interest shall be delivered physically Biratnagar Metropolitan City, Office of the Municipal Executive, Biratnagar on or before 2079/12/16 at 12.00 pm.
- 8. If the last date of Obtaining and Submission falls on a government holiday, then the next working day shall be considered as the last date.
- 9. Submitted Expressions of interest (EOI) will be opened in the presence of consultant or TPs representatives who choose to attend on 2079/12/16, 2:00 PM at the office of Biratnagar Metropolitan City.
- 10. EOI will be assessed based on Conformity with technical proposal requirements 10%, Experiences of the Bidder 20%, Training facilities available 10%, Program implementation methodology 20%, Quality of proposed key staff 40% of the Training Providers and Key Personnel. Based on evaluation of EOI, only short-listed firms will be invited to submit Technical and Financial Proposal through Request of Proposal (RFP).
- 11. Minimum score to pass the EOI is 60 points.
- 12. Biratnagar Metropolitan City reserves the right to shortlist or not shortlist any or all the applicant(s) without assigning any reason whatsoever.

B. Instructions for submission of Expression of Interest

- 1. Expression of Interest may be submitted by a sole firm. Sub-contracting, Joint Venture, and franchising shall not be allowed.
- 2. Interested consultants must provide information indicating that they are qualified to perform the training as described in TOR & Evaluation Section.
- 3. This expression of interest is open to all eligible consulting firm or Training Provider.
- A Consultant will be selected in accordance with the Quality and Cost Based Selection (QCBS) method.
- 5. Expression of Interest should contain following information:
 - (i) A covering letter addressed to the representative of the client on the official letter head of company duly signed by authorized signatory.
 - (ii) Applicants shall provide the following information in the respective formats given in the EOI document:
 - EOI Form: Eol Submission Letter (Form 1)
 - EOI Form: EoI Format to Training Provider (Form 2)
 - EOI Form: Format of Curriculum Vitae (CV) for Proposed Professional Staff (Form 3)
 - Applicants may submit additional information with their application but shortlisting will be based on the evaluation of information requested and included in the formats provided in the EOI document.
 - 7. The Expression of Interest (EOI) document must be duly completed and submitted in sealed envelope and should be clearly marked as EOI Application for Short-listing for "Conducting Training with OJT Professional Cook (Level II with 1696 hrs) and Professional welder (Level II with 1696 hrs). The Envelope should also clearly indicate the *name and address of the Applicant*. Alternatively, applicants can submit their EOI application by hand *to Biratnagar Metropolitancoty*, *Office of the Municipal Executive*, *Biratnagar*.
 - 8. The completed EOI document must be submitted on or before the date and address mentioned in the "Request for Expression of Interest". In case the submission falls on public holiday the submission can be made on the next working day. Any EOI Document received after the closing time for submission of proposals shall not be considered for evaluation.
