1. BSMC has allocated funds or received a grant from **GoN** towards the cost of Upgrading Airport Marga and intends to apply part of the funds to cover eligible payments under the Contract for **BSMC 2073/074-43**. Bidding is open to all eligible Nepalese and Foreign Bidders.
2. BSMC invites sealed bids or electronic bids from eligible bidders for the construction of Upgrading Airport Marga (Pitch Road, Drain, Footpath, Culverts etc.)<sup>2</sup> under National Competitive Bidding – **Two Envelope Bidding procedures**.

Only eligible bidders with the following key qualifications should participate in this bidding:

Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 45000000** And Minimum Work experience of similar size and nature: one project having **NRs 30000000**

5. Pre-bid meeting shall be held at **BSMC Office, Biratnagar** at 1.00 PM **2073/10/13** .
6. Sealed bids must be submitted to the office **BSMC Office, Biratnagar** by hand/courier on or before **12.00 Noon** on **2073/11/01**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2.00 P.M. 2073/11/01** at the office of **BSMC, Biratnagar**. Bids must be valid for a period of 90 Days after bid opening and must be accompanied by a bid security \_amounting to a minimum of **NRs 925000**, which shall be valid for 30 days beyond the validity period of the bid .
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
